3. Business: Write in how much your parents'/your business was worth. Use the price your parents/you would have asked for the business if it had been for sale.
(Do not use assessed, insured or Tax value. Do not list value if the Business employs 100 or less)
Business value includes that market value of land, buildings, machinery, equipment, and inventory. Business debt means only those debts for which the business was used as collateral.

4. Farm: Write in how much your and/or your parent's farm was worth. Include the value of land, buildings, machinery, equipment, livestock, inventories, etc.
(Do not include your home if you Completed 1040 Schedule F. Do not list value if the farm employs 100 or less)

Note: If you and/or your parents are NOT the sole owners, write in only their/your share of the total business and farm value and debt
