GUIDED PATHWAYS

Fall 2017 WHCC completed the [Guided Pathways Institutional Self-Assessment](#). Spring 2018 the College will complete the [Guided Pathways Work Plan](#). MULTIPLE MEASURES

In October Governor Brown signed AB 705. This bill that represents a significant shift in assessment and placement practices for the California community colleges. The bill went into effect on January 1, 2018 and includes the following changes:

The Board of Governors, not the CCC Chancellor's Office, now has the responsibility to develop and publish a list of approved assessment instruments. Once this list is published, colleges will be required to only use instruments on the approved list.

Assessment still requires the use of multiple measures, but colleges must include the use of high school transcript data (overall GPA, courses taken, or course grades) as a primary component to maximize the accuracy of student placement and increase the likelihood that students are placed into transfer-level courses in math and English. The CCC Chancellor's Office is currently working on data sharing agreements to provide high school data to the colleges. When that information is not available, the bill allows for the use of self-reported high school transcript information.

Placement recommendations must assure that students have optimized opportunities to complete transfer level math and English within one year and may not be placed into remedial prerequisite courses unless they are highly unlikely to succeed without them.

English as a Second Language students must now be placed using multiple measures and must be able to complete their language sequences within three years. AB 705 IMPLEMENTATION TIMELINE

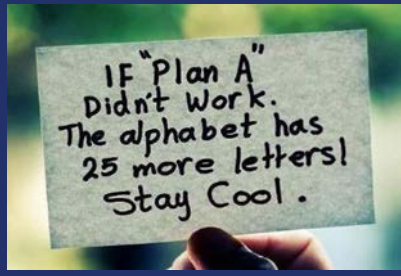
For Math and English

Timeline	Key Actions
Fall 2017	Engage stakeholders regarding current assessment practices including advisors, faculty, students, and assessment staff. Review the legal requirements of AB 705.
Spring 2018	Develop ways to make high school data primary in the assessment and placement process. Engage campus stakeholders and assessment staff with the law. Engage professional learning to support campus staff in math, English, or ESL.
Fall 2018	Develop local assessment placement practices to track high school data as a primary predictor for all students for spring 2019 placement. Prepare to meet with assessment placement data to be completed in Spring 2019. Submit locally developed curriculum changes for approval.
Spring 2019	Approve locally developed curriculum in math and English. Conduct new assessment placement trials with students. Publish new structures in college catalogs.
Fall 2019	Full compliance with AB 705.

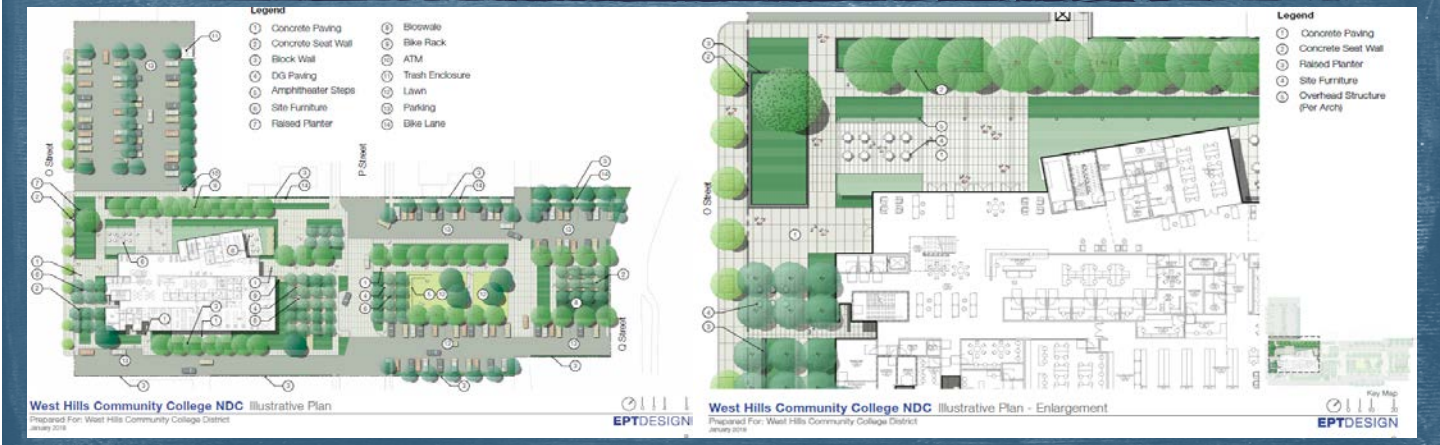
