Hi, Francisco,

I reviewed the report this weekend. Overall, you all did a good job of reporting how you addressed the recommendations. The college has done some tremendous and work and has moved far forward.

I am returning the draft report to you. I wrote marginal comments throughout the document. The feedback is meant to guide, not criticize. I give suggestions to clarify some details, delete others, and in some cases delete whole sections because they move into areas not required by the recommendations. For example, for Recommendation 9, whose emphasis is only on SLOs in instructional programs (Standard IIA), you started reporting on SSOs and AUOs. Standard IIA is only about instruction, not student services or administrative units. As you revise your report, focus only on what the recommendations ask you to fix. Do not volunteer extra information about other areas. The Follow Up Team will have extremely limited time and will want to focus only on the areas that are called out in the compliance recommendations.

Let me know if you have any questions about my feedback . . . if any of my comments are unclear. My comments are identified with SR.
