- 3.1 Institutional Set Standards J. Wanderer
  - 3.2.1 WHCC ISS (ACCJC Annual Report)
  - Recommendation #4 need numbers for 12-19. M. Matteson says that it is difficult to come up with stretch goals. However, these are floor goals. A. Hanjiev says we could get the average of what the learning areas are.
  - M. Magnuson created a spreadsheet for the ISS.
    - According to the spreadsheet they made some minor changes to it to gather accurate resutls and averages. "Reccomendations should be based on college-wide data."
  - S. Shepard thinks that we need a little bit more clarification because some learning areas developed their goals based on their own success.
  - A. Hanjiev seems to think that we shouldn't go any higher than the lower recommendation.
  - If you don't hit ISS that's supposed to trigger the college that something needs to be done. If it dips to 65% or even 60% then something is wrong and we really need to be looking at how to fix the issue. M. Magnuson. "Emergency breaks will need to go on." A. Hanjiev. 65% might be too close. M. Magnuson.
  - IEAC Recommendation 63% for course success; stretch 75%
  - IEAC Reccomendation for number of degrees is 240; stretch 300
  - MSK numbers are college wide and needs to be fixed.
  - M. Magunuson says that the counselors were unsure of the reason for the spike in degrees for 2016-2017 and that they'd like to see future data.
